As director of the MathILy summer program she was paid \$25,550, as an instructor she was paid \$7,622 in the MathILy program, \$8,239 as instructor for FaBraC, and \$2,786 for work rated to the NSF grant described in Schedule L, Part V. Emily Peters was paid \$3,049 as an instructor in the MathILy program.

Form 990, Part XII, Line 1 - The organization was required to change its method of accounting from the cash method to the accrual method according to the nonprofit corporate laws of the Commonwealth of Massachusetts because its revenues exceeded \$500,000 for the first time since incorporation. Accordingly, the organization changed from the cash to the accrual basis of accounting and has recorded a prior period adjustment in the amount of \$7,957 to reflect the cumulative effect of the change. After extensive research, it was determined that it was not necessary to file Form 3115. As evidence of this, a letter dated July 21, 2022, to Mr. Scott Vance of the Internal Revenue Service from the American Institute of Certified Public Accountants, page 13, item 6, recommends that section 3.17 of Rev. Proc. 2015-13, clearly state that exempt organizations which have no taxable income and no unrelated business income be exempt from filing Form 3115. Since Mathematical Staircase, Inc., has no taxable income, no unrelated business income, and was required by the Commonwealth of Massachusetts to make the change in accounting method, it has been determined that it was not required to file Form 3115.
